Committee Opportunities

Active participation on one or more committees enhances the networking opportunities for PEPC members as well as serve a variety of organizational objectives

Ethics: This committee meets to share ideas and encourage open discussion of current ethical issues facing members of the estate planning community. The committee meets several times throughout the year.

Membership: The Membership Committee seeks to attract qualified candidates for membership in the Council, and to retain members by continually reviewing, refining and recommending ways to enhance the overall Council experience. The Committee typically meets about six times a year.

Newsletter: This committee identifies topics for original articles that are of interest to the member's practices. It solicits authors and edits their submissions for publication in the Council's newsletter. The committee meets three to four times per year.

Program: PEPC attracts the nation's preeminent experts on estate planning matters to speak at the monthly luncheon meetings, annual seminar and roundtable discussions. This committee selects their speakers and meets three to four times a year in the fall.

Social: This committee coordinates the Council's social events throughout the year, including a Golf and Tennis Outing and Holiday Party. The Committee meets six to eight times per year.

Technology: This committee evaluates technology solutions for the benefit of its members. The Committee meets twice a year to update the PEPC web site, undertake improvements, solicit feedback and offer suggestions.

Women's Committee: This committee encourages networking and professional development for women in the Council. The committee meets four times a year.
